[THE BIBLE]	The Scriptures, consisting of the Old and New Testaments in their entirety, are the inspired and
	infallible written Word of God and have been given by God to the church as the final authority for
	what to believe and how to live.
[THE CHURCH]	The church is the people of God, made up of all who are joined to Jesus Christ through faith regardless
	of ethnicity, gender, socio-economic status or denominational association.
[HUMANITY]	All humans are sinners, disobedient to God, and have a broken relationship with Him until given new
	life by the Holy Spirit.
[SALVATION]	The only way for men and women to be in a restored relationship with God is through faith in Jesus
	Christ who, through his sacrificial death, has done all that is necessary for God to forgive our sins.
[RESURRECTION]	Jesus Christ will return personally at the end of the age when there will be a bodily resurrection of all
	people, followed by judgement leading to eternal life or eternal separation from God.
